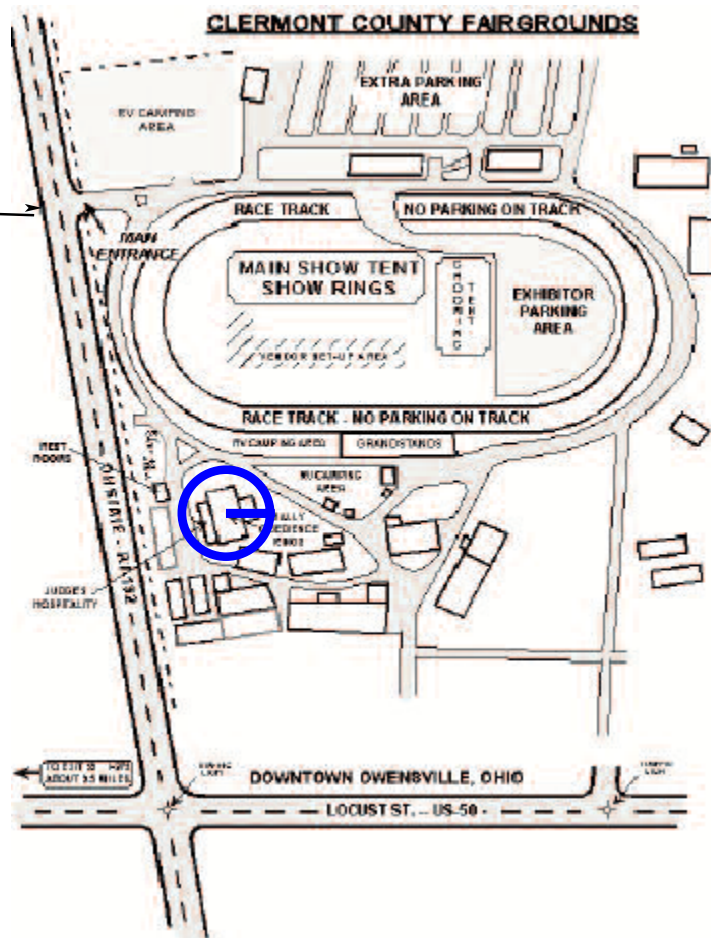

DIRECTIONS TO THE SHOW SITE

FROM THE HOST HOTEL - Turn RIGHT onto Eastgate Blvd, then exit onto Rt. 32 East (towards Batavia). Follow Rt. 32 to Batavia and take the Owensville exit (St. Rt. 132). Turn RIGHT to Owensville, then immediately RIGHT again and follow St Rt 132 approximately 5 miles to Owensville (use caution at the stop sign at the city limits as the cross traffic does not stop!); turn LEFT at the stop sign to continue following St. Rt 132. At the traffic light (in town), turn LEFT onto US Rt. 50/St Rt 132 (this will be Main St), go about a block, then turn RIGHT at traffic light onto St Rt 132 (Locust St). Turn RIGHT into Fairgrounds (gate is just past the barns) and follow the signs to the CDCA National Specialty (Multi-Purpose Building). **No Vehicle Traffic on the Race Track!** Cross race track to infield (for the Clermont County KC shows) at designated locations only.

DIRECTIONS FROM EAST/ WEST -Take I-275 from either I-71, I-74 or I-75 to the US Route 50/Hillsboro exit (Exit # 59) and turn East towards US Route 50/Hillsboro (not towards Milford Parkway). At the stoplight, turn RIGHT on US Route 50. Follow US Rt 50 into Owensville; this will be approximately 8 miles. Turn LEFT onto St Rt 132 (Locust St) at the traffic light. Turn RIGHT into Fairgrounds (gate is just past the barns).

DIRECTIONS FROM THE EAST - Take I-275 to Batavia exit (Eastgate Mall; Rt. 32 East). Stay on Rt. 32 towards Batavia and follow the above directions (From Host Hotel).

DIRECTIONS TO EMERGENCY VET CLINIC **Cincinnati Animal Referral and Emergency (CARE) Center** **6995 East Kemper Rd., Blue Ash (Cincinnati)**

FROM THE SHOW SITE: Turn RIGHT on St Rt 132 from the fairgrounds gate, then turn RIGHT onto US Rt 50 at the traffic light. Follow US Rt 50 to the Milford Parkway. Turn LEFT at the traffic light onto Milford Parkway, then turn RIGHT (North) onto I-275. Follow I-275 to the Reed Hartman Hwy (exit # 47; Blue Ash). Turn LEFT at the end of the ramp. Take a LEFT at the second stop light - there will be two left turn lanes- STAY IN THE RIGHT HAND LANE and turn LEFT. This will “swing” you up to another stop light. Turn RIGHT at that light; this is E. Kemper Rd. Once you’re on E. Kemper, go through two traffic lights and the clinic will be at the third stop light on the RIGHT.
