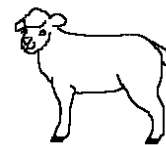
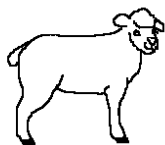

LIMITED TO 15 DOGS (RUNS)!!!

Runs will be limited as follows: 10 runs reserved for those dogs being tested for the first time for the HC title and 5 runs reserved for those dogs requiring 2nd or 3rd legs for their HCX title

NOTE: If there are any available run slots at the end of the test, a random draw lottery will be held to allow that number of entered dogs a chance for a 2nd run with a possible qualifying leg to participate. If all available slots following the random draw are still not filled, "For Exhibition Only" dogs may be allowed to participate. If there are more FEO dogs than available slots, a second random draw lottery will be held.
